In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Renewal of Recognition of MD(Anatomy) qualification for 02 seats in respect of students being trained at Yenepoya Medical College, Mangalore under Yenepoya (Deemed to be University), Mangalore**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (i) The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the date of issue, upon which it shall have to be renewed.
- (ii) The procedure for 'Renewal of Recognition' shall be same as applicable for the award of recognition.
- (iii) Failure to seek timely renewal of recognition as required in sub-clause (i) supra shall invariably result in stoppage of admissions to the concerned Post Graduate Course of the said institute.
