(This shall be a recognised medical qualification when granted by Rajasthan University of Health Sciences, Jaipur, Rajasthan in respect of students being trained at S.P. Medical College, Bikaner, Rajasthan on or after June, 2013.

"Doctor of Medicine/Master of Surgery(Anatomy)"

MD/MS(Anatomy)

(This shall be a recognised medical qualification when granted by Rajasthan University of Health Sciences, Jaipur, Rajasthan in respect of students being trained at S.P. Medical College, Bikaner, Rajasthan on or after 1974.

b) against "Maharashtra University of Health Sciences, Nashik, Maharashtra" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Doctor of Medicine/Master of Surgery(Anatomy)"

MD/MS(Anatomy)

(This shall be a recognised medical qualification when granted by Maharashtra University of Health Sciences, Nashik, Maharashtra in respect of students being trained at Shri Vasant Rao Naik Govt. Medical College, Yavatmal, Maharashtra on or after May, 2013.

"Doctor of Medicine(Microbiology)"

MD(Microbiology)

(This shall be a recognised medical qualification when granted by Maharashtra University of Health Sciences, Nashik, Maharashtra in respect of students being trained at Shri Vasant Rao Naik Govt. Medical College, Yavatmal, Maharashtra on or after May, 2013.

c) against "Sri Ramachandra University(Deemed University), Porur, Chennai" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Doctor of Medicine(Sports Medicine)"

MD(Sports Medicine)"

(This shall be a recognised medical qualification when granted by Sri Ramachandra University(Deemed University), Porur, Chennai in respect of the students being trained at Sri Ramachandra Medical College & Research Institute, Porur, Chennai, Tamil Nadu on or after June, 2013.

d) against "Krishna Institute of Medical Sciences University(Deemed University), Karad, Maharashtra" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Master of Surgery(Ophthalmology)"

M·S(Ophthalmology)

(This shall be a recognised medical qualification when granted by Krishna Institute of Medical Sciences University(Deemed University), Karad, Maharashtra in respect of students being trained at Krishna Institute of Medical Sciences, Karad, Maharashtra on or after May, 2013.

"Master of Surgery(Oto-Rhino-Laryngology)"

MS(ENT)

(This shall be a recognised medical qualification when granted by Krishna Institute of Medical Sciences University(Deemed University), Karad, Maharashtra in respect of students being trained at Krishna Institute of Medical Sciences, Karad, Maharashtra on or after May, 2013.

e) against "Guru Gobind Singh Indraprastha University, New Delhi" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Doctor of Medicine(Biochemistry)"

MD(Biochemistry)

(This shall be a recognised medical qualification when granted by Guru Gobind Singh Indraprastha University, New Delhi in respect of students being trained at Vardhman Mahavir Medical

Mca 2874/m

College & Postgraduate Institute, Safdarjung Hospital, New Delhi on or after April, 2013.

f) against "Yenepoya University, Mangalore, Karnataka" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Doctor of Medicine(Psychiatry)"

MD(Psychatry)

(This shall be a recognised medical qualification when granted by Yenepoya University, Mangalore, Karnataka in respect of students being trained at Yenepoya Medical College, Mangalore, Karnataka on or after April, 2013.

g) against "Gujarat University, Ahmedabad, Gujarat" under the heading 'Recognised Medical Qualification' [hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [hereinafter referred to as column (3)], the following shall be inserted, namely:-

"Doctor of Medicine(Biochemistry)"

MD(Biochemistry)

(This shall be a recognised medical qualification when granted by Gujarat University, Ahmedabad, Gujarat in respect of students being trained at Smt. N.H.L. Municipal Medical College, Ahmedabad, Gujarat on or after 2011.

Note to all: 1.The recognition so granted to a Postgraduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.

2. Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Postgraduate Course.
